Johnson called to Meeting to Order

Roll Call – All officers present

Acknowledge of Agenda and Statement of Compliance with Open Meeting Act

TO MEET, DISCUSS, AND TAKE POSSIBLE ACTION ON THE FOLLOWING AGENDA ITEMS:

Ross moved to approve the minutes and Claflin seconded. Ross, voted aye, Johnson voted aye, M. Roach, J. Roach Wallace voted aye, Miller voted aye, Claflin voted aye, and Schwerdtfeger voted aye.

Estimate of Needs – Schwerdtfeger handed out a spreadsheet with prior year, previous year and current year Estimate of Needs. There was a short discussion on where we could cut, she stated she could get a projected amount to balance with if the officers would like to speed up the process of cutting before the Budget Maker received their requests.

She stated that there was probably 77 different ways that counties were doing this, but they needed to decide so the Estimate Needs could be changed.

Update from Officers:

Sheriff Wallace – normal business taking care of thinks, have seven inmates, deputies are helping with oilfield thieves again, and he stated he will be out of office for surgery April 29th for three weeks. He also stated his Exit Audit will be June 3rd.

Court Clerk Miller – Wednesday is Civil Docket, Monday is Juvenile Docket, Court Clerk School is in July in OKC Treasurer Claflin – collecting taxes, getting ready for June Resale, and Treasurer School is in Durant

Assessor J. Roach – completed assessment period, after April 15th there is a 20% penalty, she stated she had already received a few informal complaints, and received ten oil/gas values from TASC, Seth would be ready withing a month to go out on visual inspection.

County Clerk Schwerdtfeger – She thanked Ross for keeping us updated on Legislation, their traffic was slow but the mail and e-file filings were still coming in strong, working on Estimate of Needs, she has three more classes and she will be finished, and Heather is still going to class. She stated County Clerk school was May 1-3 in Durant also.

Commissioner Dist #1 Johnson – business as usual, ODOT should be opening the bridge south of the road going to Kiowa.

Commissioner Dist #2 M. Roach – everyday business as usual

Commissioner Dist #3 Ross – hauling rock, putting pipes in, taking care of legislative issues, House Bills in Senate are being held up, he discussed several bills that had passed or were out.
